SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

General: Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

Inhalation: When symptoms occur: go into open air and ventilate suspected area. Obtain medical attention if breathing difficulty persists.

Skin Contact: Remove contaminated clothing. Immediately drench affected area with water for at least 15 minutes. If exposed or concerned: Get medical advice/attention. Obtain medical attention if irritation/rash develops or persists.

4.2. Most Important Symptoms and Effects Both Acute and Delayed

General: May cause cancer by inhalation. Causes damage to organs (lungs, respiratory tract) through prolonged or repeated exposure (Inhalation). May cause respiratory irritation. Skin sensitization. Causes skin irritation. Causes serious eye damage.

Inhalation: Some studies show that exposure to respirable crystalline silica (without silicosis) or that the disease silicosis may be associated with the increased incidence of several autoimmune disorders such as scleroderma (thickening of the skin), systemic lupus erythematosus, rheumatoid arthritis and diseases affecting the kidneys. Silicosis increases the risk of tuberculosis. Some studies show an increased incidence of chronic kidney disease and end-stage renal disease in workers exposed to respirable crystalline silica. Irritation of the respiratory tract and the other mucous membranes.

Skin Contact: May cause skin to become dry or cracked. May cause an allergic skin reaction. Redness, pain, swelling, itching, burning, dryness, and dermatitis.

Eye Contact: Concrete may cause immediate or delayed irritation or inflammation. Eye contact with wet concrete can cause moderate eye irritation, chemical burns and blindness. Eye contact with large amounts of concrete dust can cause moderate eye irritation and abrasion. Eye exposures require immediate first aid and medical attention to prevent significant damage to the eye. **Ingestion:** Ingestion may cause adverse effects.

Chronic Symptoms: Long term exposure to respirable crystalline silica results in a significant risk of developing silicosis and other non-malignant respiratory disease, lung cancer, kidney effects, and immune system effects.

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Suitable Extinguishing Media: Water spray, dry chemical, foam, carbon dioxide.

Unsuitable Extinguishing Media: Do not use a heavy water stream. Use of heavy stream of water may spread fire.

5.2. Special Hazards Arising From the Substance or Mixture

Fire Hazard: Not considered flammable but may burn at high temperatures.

Explosion Hazard: Product is not explosive.

Reactivity: Wet cement is alkaline. As such it is incompatible with acids, ammonium salts, and aluminum metal. Hazardous reactions will not occur under normal conditions.
